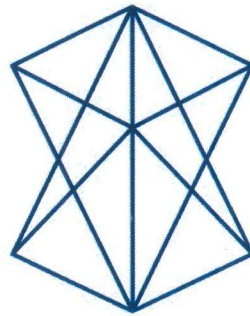





6.2 **Certification** - Autodesk certifications validate skills and knowledge in Autodesk products to advance student careers in engineering, digital arts, and architecture.

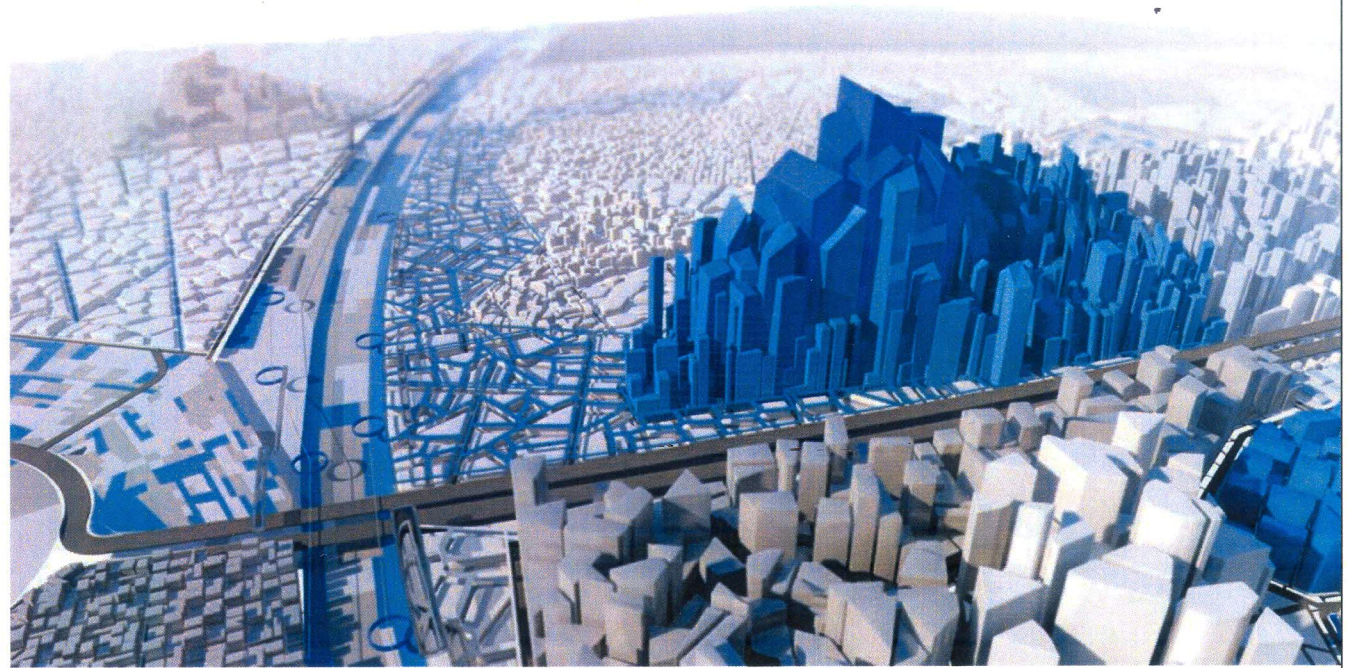

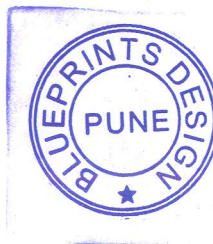

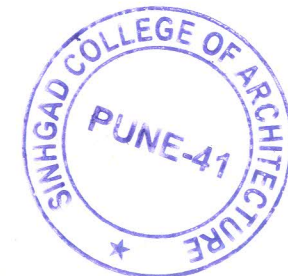
