I am directed to state that the Executive Committee of the Council of Architecture (COA), considered the reply/information submitted by your institution in response to clarification sought by the Council regarding conduct of Master of Architecture (M.Arch.) degree course for the academic session 2021-2022.

Accordingly, the Executive Committee of the Council, based on the reply furnished by your institution, has decided to fix the intake of your institution in the M.Arch. degree course as under:

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as Annexure-A. The approval accorded to your institution shall be subject to appointment of adequate Faculty of Architecture at your institution as per Council Norms, prior to commencement of academic session 2021-2022. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The final observations of the Executive Committee are mentioned below for your information and compliance:

- Adequate Infrastructure and cadre-wise qualified faculty as per COA Norms must be appointed/ maintained by the institution at all times.
- Salary to faculty must be paid as per COA/UGC Norms.

The institution shall initiate necessary remedial actions, if any, based on the observations of the Executive Committee & Inspection Committee and send its compliance/observations on the same for further consideration. The Council shall be at liberty to inspect the Institution at any point of time to assess the Minimum Standards of Architectural Education prescribed by the Council and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time. In case the institution is found to be imparting deficient education during 2021-2022, the appropriate action shall be initiated against it.
