The Executive Committee, after considering the same, has decided to grant extension of approval to Master of Architecture (M.Arch.) degree course as under:

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as **Annexure-A**. The approval accorded to your institution shall be subject to appointment of adequate Faculty of Architecture at your institution as per Council Norms, prior to commencement of academic session 2020-2021. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The following observation of the Executive Committee are mentioned below for your information and compliance:

- The institution must recruit one Associate Professor.
- The institution must engage more visiting faculty from all cadres.

The institution shall be required to submit its compliance to the Council before making any admissions in the course.





The Council shall be at liberty to inspect the Institution at any point of time to assess the Minimum Standards of Architectural Education prescribed by the Council and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time. In case the institution is found to be imparting deficient education during 2020-2021, the appropriate action shall be initiated against it.
